### Additional Price Reduction:

- When notifying more than six first publications/product changes of a price variant within one billing period, the price per PZN is further deducted. The price is calculated according to the following formula: (number of first publications/product changes x 1.5)<sup>0.8</sup> x price

### Notes:

- Services will be billed as *early* if the complete order is received by the respective early deadline for first publications/changes (cf. [IFA Publication Calendar](#)), all others will be billed as *at short notice*.
- Services ordered via the IFA portal or by means of Electronic Order File (EAD) will be charged as *IFA portal/EAD*, all others as *other notifications*.
- PZN Pre-Allocations, first publications and changes are invoiced at the end of the quarter.
- All invoices are due within two weeks net without deduction.
- All prices are subject to German VAT.
